

- Copyright policy: Open Access journal/book copyright/licensing policy

In order for Vesnu Pub to publish and disseminate research articles and books, we need publishing rights. This is determined by a publishing agreement between the author and Vesnu Pub. This agreement deals with the transfer or license of the copyright to Vesnu Pub and authors retain significant rights to use and share their own published articles. Vesnu Pub supports the need for authors to share, disseminate and maximize the impact of their research. For open access articles, Authors sign an exclusive license agreement, where authors have copyright but license exclusive rights in their article to the publisher. In this case authors have the right to: Share their article in the same ways permitted to third parties under the relevant user license (together with Personal Use rights); Retain patent, trademark and other intellectual property rights (including research data); and Proper attribution and credit for the published work.

For both subscription and open access articles, published in proprietary titles, Vesnu Pub is granted the following rights:

- *The exclusive right to publish and distribute an article, and to grant rights to others, including for commercial purposes.*
- *For open access articles, Vesnu Pub will apply the relevant third party user license where Vesnu Pub publishes the article on its online platforms.*
- *The right to provide the article in all forms and media so the article can be used on the latest technology even after publication.*
- *The authority to enforce the rights in the article, on behalf of an author, against third parties, for example in the case of plagiarism or copyright infringement.*

As a general rule, permission should be sought from the rights holder to reproduce any substantial part of a copyrighted work. This includes any text, illustrations, charts, tables, photographs, or other material from previously published sources. Obtaining permission to re-use content published by Vesnu Pub is simple; you just need to make your request through this email address “x@y” to seek permission.

- Complaint policy

With regards to Plagiarism complaints we follow COPE flowcharts:

The editor of a learned journal is solely and independently responsible for deciding which articles submitted to the journal shall be published. Article withdrawal is only used for Articles in Press which represent early versions of articles. Such articles may represent infringements of professional ethical codes, such as multiple submission, bogus claims of authorship, plagiarism, fraudulent use of data or the like. Article retraction is taken place in case of infringements of professional ethical codes, such as multiple submission, bogus claims of authorship, plagiarism, fraudulent use of data or the like whenever disclosed.

- Publication charge policy

Vesnu Pub publishes journal articles under two separate business models:

- *Subscription articles whose publication is funded by payments that are made by subscribing individuals or institutions.*
- *Open access articles whose publication is funded by payments that are made by authors, their institution or funding bodies, commonly known as Article Publishing Charges (APCs).*

Vesnu Pub separately calculates pricing for each of these business models. Subscription prices are set independent of open access articles, and open access articles are not considered when setting subscription prices.

- Standards and procedures for ensuring the quality of journals

We adhere to the COPE's "[Codes of Conduct and Best Practice Guidelines](#)" and encourage our journal's editors and reviewers to comply with this guideline. We also follow "Best Practice Guidelines on Publication Ethics" outlined [here](#) by Blackwell: 1. Transparency; 2. Authorship and acknowledgment; 3. Collecting authorship information; 4. Attributing authorship to a group; 5. Redundant (multiple) publication; 6. Registering clinical trials; 7. Protecting research subjects, patients and experimental animals; 8. Respecting confidentiality; 9. Errata, Retractions, Expressions of concern; 10. Publishing work from a journal's own staff; 11. Timing of publication; 12. Conflicts of interest; 13. Commercial issues; 14. Supplements and other funded publications; 15. Protecting intellectual property.
